ORDER

Subject: Formulation of the Twelfth Five Year Plan (2012-17) – Constitution of Steering Committee for Secondary and Vocational Education– regarding.

In the context of the formulation of the Twelfth Five Year Plan (2012-17) for the Education sector, it has been decided to set up a Steering Committee on Secondary and Vocational Education.

2. The Composition of the Steering Committee is at Annexure I
3. The Terms of Reference are as follows:-
 - a) To review the current status, formulate the strategy and to identify the priority areas for providing quality basic education, enhancing access to and improving quality of secondary and vocational education.
 - b) To oversee and provide all necessary guidance to the Working Groups/Task Force.
 - c) To work out the financial requirements for various schemes and programmes for providing quality basic education up to Class X and further up to Class XII, and outlays for the Twelfth Five Year Plan.
4. The expenses towards TA/DA of the official members will be met by the respective Governments/Departments/Institutions to which they belong. Non-official members will be entitled to travel only by Executive Class of Air India and their expenditure towards TA/DA (as admissible to Grade I officers of the Government of India) will be paid by the Planning Commission.
5. The Chairperson of the Steering Committee, if deemed necessary, may constitute Sub-Groups/ Taskforce and/or may co-opt additional members.
6. The Steering Committee will submit its report by 30th November 2011.
