Subject:- Formulation of the Twelfth Five Year Plan (2012-17) Constitution of Steering Committee for Youth Affairs & Sports – reg.

In the context of the formulation of the Twelfth Five Year Plan (2012-17) for the Youth Affairs and Sports Sector, it has been decided to set up a Steering Committee for Youth Affairs and Sports.

2. The composition of the Steering Committee is at Annexure-I.
3. The Terms of Reference (TOR) of the Steering Committee are as follows:
 - a. To review the current status of the sector, to identify thrust areas for development of the Youth & Sports, to formulate the broad objectives and to provide the focus for development of the Sector along with synergization with other related sectors during the Twelfth Five Year Plan;
 - b. To oversee and to provide all necessary guidance to the Working Groups in all respects.
 - c. To consider the recommendations of the Working Groups and work out the financial requirement and outlays for various schemes/programmes for achieving the goals and objectives of the sector and setting up of monitorable outcomes for 12th Plan.
 - d. To work out an operational strategy for implementation of recommendations of the Working Group/Task Force/Committees etc. set up for the sector and to suggest changes, if any.
4. The Chairperson of the Steering Committee, if deemed necessary, may constitute Sub-Groups/task force and/or co-opt additional members.
5. The expenses towards TA/DA etc. of the official members in connection with the meetings of the Steering Committee will be borne by the respective Government/ Departments/ Institutions to which they belong. Non-official members will be entitled to travel only by Executive Class of Air India and their expenditure towards TA/DA (as admissible to Grade I officers of the Government of India) will be paid by the Planning Commission.
6. The Steering Committee will submit its report by 30th November, 2011.
