2. The Terms of Reference of the working group will be as under:

- a) To review the nature and magnitude of child labour in the country, region wise.
- b) To make an assessment of child workers in hazardous occupations.
- c) To review the exiting programmes for the rehabilitation of child labour and progress made in the 11th Five Year Plan.
- d) To review the present approach for combating the problem of child labour and suggest ways and means for mitigating the evil of child labour.
- e) To suggest appropriate measures under taken for dealing with the problems in rehabilitating the child worker.
- f) To suggest modalities for utilizing the activities in other (than labour) development head in Central Sector and in the State Sector to curb evil of child labour.
- g) To examine the relevant Act(s), the manner of their implementation, in particular those concerning child labour.
- h) To review the existing situation of bonded labour and suggest effective measures for their proper rehabilitation.
- i) To review the existing situation of migrant labour and suggest effective ways and means to ensure better working conditions and security.
- j) Any other issue(s) concerning Child Labour, Bonded Labour, Migrant Labour and other vulnerable groups with the consent of the Chairman of the Working Group.

3. The Chairman of the Working Group may co-opt any other person as Member of the Working Group if considered necessary.

4. The Working Group will submit its report by 31st July, 2011.

5. The expenditure on TA/DA in connection with the meetings of the Working Group in respect of the official members will be borne by the respective Ministry/Department. **Non-official members of the Working Group will be entitled for TA/DA as admissible to Grade I officers of the Government of India. (Travel entitlement by Air India/Indian Air Lines [Economy class] only.)** This would be met by the Ministry of Labour & Employment.
