The identity proof of self \ residential address shall also require to be submitted before the auction.

Terms and Conditions

1. The bidders may inspect the items on date and time indicated in the Auction Notice and satisfies themselves about the items they are bidding for.
2. Since it would be an open bid, No Sealed Quotations will be accepted. Auction shall be made on 'as is where is basis'.
3. Auction will be carried out / sold out with full quantity of condemned material and not in pieces.
4. Amount would be quoted for the lot as a whole. The minimum reserve price fixed for the bid is ₹.2,50,000\-. (Rupees two lakh fifty thousand only).
5. No items, once disposed to the highest bidder shall be taken back by Planning Commission under any circumstances whatsoever.
6. The highest bidder will be required to deposit at least 25% of the bid value on the day of auction by cash or Demand Draft \ Pay Order drawn in favour of 'The Pay and Accounts Officer, Planning Commission, New Delhi, payable at New Delhi issued by any Commercial Bank.
7. The highest bidder will make the balance payment of 75% in full, in the form of Demand Draft \ Pay Order in favour of "Pay and Accounts Officer, Planning Commission", by 05:00 PM on 10th April 2012, failing which the offer will be cancelled and 25% of amount deposited shall stand forfeited.
8. The Highest bidder shall be required to lift all the items from the disposal site within 5 days after the payment of the full amount i.e., by 15th April 2012.
9. The Highest bidder should ensure himself that the whole auctioned lot is removed and in case any item left at site, the same shall be thrown away at the risk and cost of highest bidder.
10. The labour, cartage and other expenses shall be borne by the highest bidder.
11. The terms and conditions are not exhaustive but general in nature. Planning Commission shall have the right to clarify any clause or part thereof the terms and conditions and that will be final and binding.
12. The highest bidder shall be decided based on total monetary value of items quoted by the bidders in the auction.
