

The sale will be governed by the following terms and conditions:

- i) The bidder is required to pay an Earnest Money Deposit of 7.5% of the amount quoted by him for the concerned vehicle payable by means of Demand Draft drawn in favour of Pay and Accounts Officer, Planning Commission, New Delhi.
 - ii) Quotation received without demand draft towards earnest money deposit will not be considered and shall not be accepted.
 - iii) The successful bidder will be required to deposit the rest of the bid amount (90% of the quoted amount) by means of cash/demand draft drawn in favour of Pay and Accounts Officer, Planning Commission, New Delhi, within three working days of the acceptance of the bid.
 - iv) The Earnest Money Deposit of the successful bidder stands forfeited in case of non deposit of 90% of the quoted amount. The offer too, would stand cancelled automatically and an offer would be made to the second highest bidder.
 - v) The delivery of the sold vehicle shall be made after the successful bidder submits documentary evidence in support of residential status viz. Ration Card/Voter Identity Card/Passport in case of individual and Registration Certificate in case of firms, etc. and this formality will have to be completed within 5 days from the date of issue of letter to him in this regard.
 - vi) The sold vehicle will be removed by the successful bidder within five working days of depositing the money at their own expense after which a penalty of Rs. 500/- per day will be charged.
 - vii) The vehicle will be disposed of on 'as is where is' basis and no guarantee for its worthiness or quality will be given by Planning Commission.
 - viii) The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously. Planning Commission will not be responsible for any lapse on his part in this regard.
 - ix) The bidder will not be allowed to withdraw their bids, failing which their Earnest Money will be forfeited.
 - x) The Competent Authority in Planning Commission reserves the right to accept or reject any/all of the quotations without assigning any reason therefor.
