



1. All the above mentioned items will be disposed off in one lot to the successful bidder and no part quotation will be entertained.
2. The bidders may inspect the items on the days given in the disposal/sale notice and satisfy themselves of the items that they are bidding for.
3. The items shall be sold to highest bidder.
4. The Earnest Money Deposit (EMD) of the successful bidder shall be adjusted in the bid forthwith. The EMD of the unsuccessful bidder shall be returned after the final decision of successful bidder of the auction without any interest.
5. Items once disposed off to the successful bidders shall not be taken back by Planning Commission under any circumstances whatsoever.

6. The successful bidder has to make full balance payment in the form of Account Payee Demand Draft of a Commercial Bank in favour of Pay and Account Officer, Planning Commission payable at New Delhi within five days after confirmation, failing which the offer will be cancelled and EMD shall stand forfeited.
