Sir,

I am directed to refer to the Government of N.C.T. of Delhi's letter No. F.18(8A)/2010-11/Monit./Plg./8466 dated 20.09.2011 on the above subject and to convey the approval of Planning Commission for the Sectoral break-up of the Plan outlay of Rs. 15,133 crores.

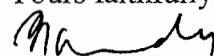
2. The Scheme of Financing of the agreed outlay of Annual Plan 2011-12 is given at Annexure-I.
3. A statement showing the distribution of Approved Plan outlay under different heads and sub-heads of development is given at Annexure-II.
4. The proportion of SC population in Delhi is 16.9% as per 2001 census. As per SCSP guidelines 16.9% i.e. Rs. 2557.48 crore of the total outlay should have been earmarked for the SC Sub-Plan. But in the current proposal of Govt. of N.C.T. of Delhi, no earmarking has been provided for the SC Sub-Plan. ***The approval is subject to the condition that the Govt. of NCT of Delhi will provide an earmarking of 16.9% of the total plan outlay for the SCSP by the RE stage.***
5. Your attention is invited to the procedure for sending adjustment proposal and revision of outlays and request you to send adjustment proposal and proposal for revision of outlays fully supported by the Revised Scheme of Financing (SOF) for the Annual Plan 2011-12, if any, together with appropriate justification, before **December 31, 2011**.
6. Statements showing actual expenditure incurred and the corresponding actual SOF of the Annual Plan 2011-12 could be sent to the Planning Commission before **September 30, 2012**.
