Sub: Constitution of State Level Project Steering Committee to oversee the implementation of GOI-UNDP Project "Human Development towards Bridging Inequalities (HDBI)".

Planning Commission, Government of India and the UNDP have jointly conceptualized a project, "Human Development towards Bridging Inequalities (HDBI)". The Project aims at: (i) preparing second Human Development Report (HDR) of Odisha, (ii) training and capacity building of 30 District Planning and Monitoring Units, (iii) training and capacity building of officials of State Planning Machinery, Directorate of Economics and Statistics (DES), and Poverty & Human Development Monitoring Agency (PHDMA), (iv) strengthening statistical Systems to provide HD data on an annual basis, (v) promoting and mainstreaming Human Development in the planning process, and (vi) undertaking thematic studies and community monitoring of the Human Development Programme. The Government in P & C Department have decided to implement the project in Odisha with support from Planning Commission and UNDP. The Government have entrusted the responsibility to implement the aforesaid project to the "Poverty and Human Development Monitoring Agency (PHDMA)" that has been created vide this Department Resolution No. 9038/P dated 16th June, 2005.

3. The Chairperson shall have the authority to invite any official / authority / organisation to the meeting as per the requirement. The State Level Project Steering Committee has been entrusted with the overall responsibility for overseeing the implementation of the project. The Committee shall devise its own rules of business.

Functions of the Committee

4. The main functions of the State Level Project Steering Committee shall be as follows.

- (i) The Committee shall be responsible for overall effective implementation of the "Human Development towards Bridging Inequalities HDBI" project and also see that the approved programmes are properly implemented and prescribed milestones are achieved.
- (ii) The Committee shall also advise for organising workshops, training programmes and capacity building of the DES, DPMU at the district level, and PHDMA.
- (iii) The Committee shall finalise relevant thematic and other studies relating to the HDBI project and also approve the final reports. The Committee may also suggest modalities for strengthening the existing system for undertaking surveys / studies.
- (iv) The Committee shall also review progress periodically and address bottlenecks and hurdles, if any, in the implementation process. The Committee may coordinate activities of different Departments, connected with the implementation of programmes and, if necessary, to suggest appropriate action to the concerned line departments.
- (v) The Committee shall also discharge such other responsibilities as may be assigned to it by Government from time to time.

ORDER: Ordered that the Resolution be published in the Odisha Gazette and copies thereof forwarded to all Departments to Government / all Heads of Department / Secretary to Governor / Secretary to Chief Minister.
